ARTICLES OF ORGANIZATION  
OF  
GLOBAL VEHICLE PARKING, LLC

The undersigned, under Chapter 608 of the Florida Statutes, for the purposes of forming a limited liability company under the laws of the State of Florida, sets forth the following:

ARTICLE I – Name:

The name of the limited liability company is Global Vehicle Parking, LLC.

ARTICLE II – Address

The mailing address and street address of the principal office of the limited liability company is 5454 Hoffner Avenue, Suite 102, Orlando, Florida 32812.

ARTICLE III – Purpose

The purpose for which the Company is organized is to engage in the operation and management of parking facilities and any and all other business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

ARTICLE IV - Duration

The period of duration for the Company shall be perpetual, unless terminated in accordance with the Act or the **Operating Agreement**.

ARTICLE V – Management

The overall management and control of the business and affairs of the Company shall be vested in its members, as provided in these Articles of Organization and Section 608.407 of the Act. Any and all action by the company shall require the vote of members holding a majority interest in the Company.

ARTICLE VI– Members

The Company shall have at least one member and may admit additional members on the prior unanimous written agreement of the then- existing members, or as otherwise provided in the Operating Agreement.

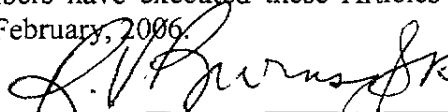
#### ARTICLE VIII – Capital Contributions

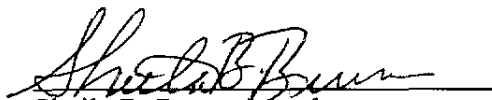

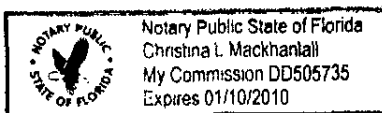

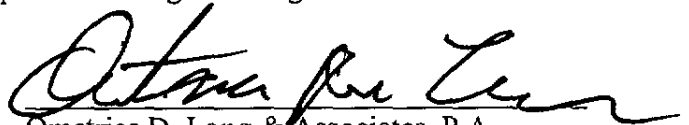
