ARTICLES OF ORGANIZATION OF GLOBAL VEHICLE PARKING, LLC

The undersigned, under Chapter 608 of the Florida Statutes, for the purposes of forming a limited liability company under the laws of the State of Florida, sets forth the following:

ARTICLE I – Name:

The name of the limited liability company is Global Vehicle Parking, LLC.

ARTICLE II – Address

The mailing address and street address of the principal office of the limited liability company is 5454 Hoffner Avenue, Suite 102, Orlando, Florida 32812.

ARTICLE III – Purpose

The purpose for which the Company is organized is to engage in the operation and management of parking facilities and any and all other business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

ARTICLE IV - Duration

ARTICLE VII - Initial Registered Agent and Office

ARTICLE VIII - Capital Contributions

Contributions to the Capital of the Company shall be made by the members, in the manner presented in the Operating Agreement, and which may be amended from time to time in accordance with its terms. Except as expressly provided in the Operating Agreement, the Company shall identify any member, manger or former member or manager to the full extent permitted under the Act

ARTICLE IX - Continuation of Business

Unless dissolved in accordance with the Operating Agreement, the remaining members shall continue the business of the Company, which shall not be dissolved, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member.
