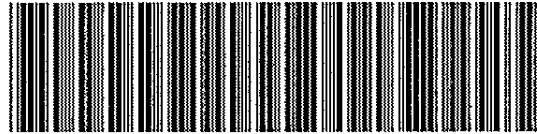

**Article One -- Purpose Clause**
