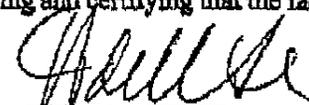
The Company is to be managed by its members in accordance with the terms of the Operating Agreement.

COMMENCEMENT DATE**

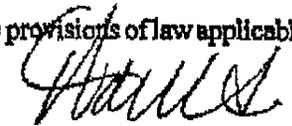
Existence of the Company will commence upon the filing of these Articles.
