The name of this limited liability company shall be McJero Property Holdings, LLC.

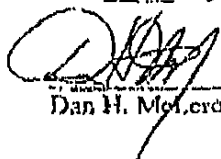
2. The Articles of Organization of this limited liability company were duly filed with the Florida Department of State on March 9, 2006, and assigned Document Number 1.06000025702.

5. This amendment shall be effective immediately upon filing.

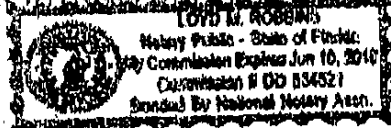

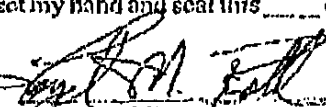
