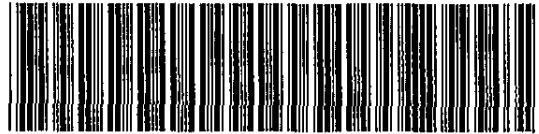

ARTICLES OF ORGANIZATION

OF

J.D.M., L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be J.D.M., L.L.C. ("company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company is 2345 14th Avenue, Suite #6, Vero Beach, Florida 32961

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date if specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the state of Florida is Joseph Telese, Jr. 2345 14th Avenue, Suite #6, Vero Beach, Florida 32961.

ARTICLE V -- MANAGEMENT

The Company shall be managed by one or more Managing Members elected from time to time by the members and is, therefore, a manager-managed company. Only Members of the Company shall be eligible for election as a Manager Member. The initial Manager Member of the company shall be Joseph Telese, Jr.

ARTICLE V -- LIMITATION ON AGENCY AUTHORITY OF MEMBERS:


Pursuant to section 608.4235 of the Florida Limited Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member.


