**ARTICLES OF ORGANIZATION
OF
SOUND INVESTMENT PUBLISHING, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company.

**ARTICLE I
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is SOUND INVESTMENT PUBLISHING, LLC.

**ARTICLE II
ADDRESS**

The Company's street address of its principal place of business in Florida is 6709 Grand Bahama Drive, Tampa, Florida 33615 and its mailing address is the same, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the Member or Members.

**ARTICLE III

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Section 608 of the Florida Statutes, as shall be prescribed by the Department of State, and shall be signed and sworn to by all Members of the Company.

These Articles shall be effective upon filing with the Florida Secretary of State.
