

ARTICLES OF ORGANIZATION OF

MARC TEN DEVELOPMENT, LLC
a Florida Limited Liability Company

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. NAME. The name of the Limited Liability Company is MARC TEN DEVELOPMENT, LLC (the "Company").
2. PERIOD OF DURATION. The period of duration of the Company shall be perpetual.
3. PURPOSE. The purpose for which the Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida and, more specifically, the business of buying and developing properties. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.




