ARTICLES OF ORGANIZATION

In consideration of the mutual covenants contained in these Articles of Organization, the undersigned members do hereby form a limited liability company pursuant to Chapter 608 of the Florida Statutes:

ARTICLE I

The name of the limited liability company shall be L & N AUTO FINDER, LLC.

ARTICLE II

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or an another effective date if specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization.

ARTICLE III

The mailing and the street address of the principal office of this limited liability company is 3700 S.W. 165th Avenue, Miramer, FL 33027.

ARTICLE IV
