


- Please be advised that one of the two original Managing Members of the above named company Margarette Occenad is, as of this date, September 18, 2010, no longer a part of this company, and has not been so from the day of her Resignation October 15, 2009.
- The Board of Directors at it's last meeting and with full consideration, has acknowledged, and accepted her resignation and it was the decision of the Board to remove her from any and all operations of this company, which was the direction of the Board, directly following her Resignation and communications from her of her desire to not be involved and/or connected with Ankod. There is no financial liability due from Ankod to Margarette Occenad.
- Margarette Occenad, without the approval of the company and the knowledge of the one other Managing Partner, Sandra M. Moody, did dissolve the company, and did so after her resignation from Ankod, which the Board feels was done with ill intent, and disregard for Ankod.
