ARTICLES OF ORGANIZATION 2006 MAR 14 A 11: 2



4 F, LLC.

The undersigned certify that we have associated ourselves together for the purpose of TAT becoming a limited liability company under the laws of the State of Florida, providing for  $disc_{R/DA}$ formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

## ARTICLE I. NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be 4-F, LLC., and its principal office shall be located at 2115 Corporate Drive, Boynton Beach, Florida 33426, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.
