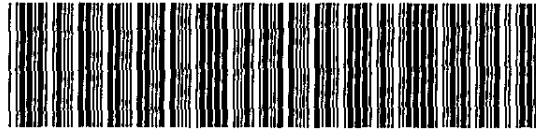

1. **ARTICLES OF ORGANIZATION.**

**ARTICLE I
NAME**

The name of the Limited Liability Company is as follows:

GOVERNANCE AND OPERATION


