8. **Effective Date:** These Articles of Amendment shall be effective upon filing.

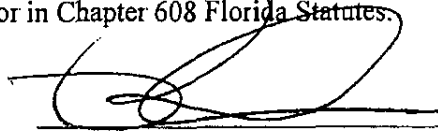
