To the full extent permitted by the Act and any other applicable laws presently or hereafter in effect each Manager and Member shall be indemnified by this Company against all liabilities, costs and expenses reasonably incurred by or imposed upon him or her in connection with or resulting from any civil or criminal action, suit or proceeding to which he or she may be made a party by reason of his or her being or having been a Manager or Member of this Company except in relation to matters in which he or she has been fully adjudged in such action, suit or proceeding to be liable for willful misconduct or conscious disregard for the best interests of the limited liability company in the performance of duties for the Company. The foregoing right of indemnity shall be in addition to and not in limitation of other rights to which any such accused Manager or Member may be entitled as a matter of law.
