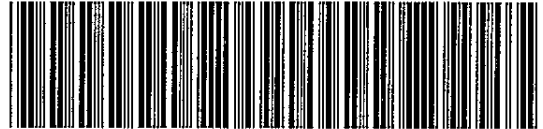

The Member has agreed that the equity in the company shall be represented in the following manner:

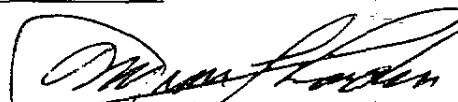

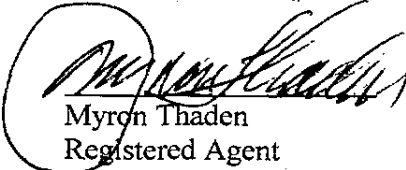
CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE
