

**RESTRICTIONS ON MEMBERSHIP**



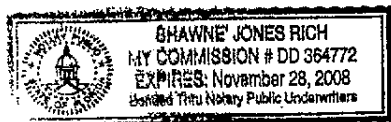


