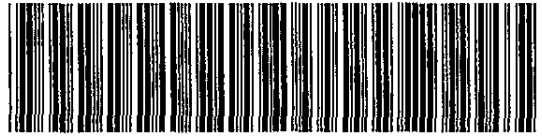

ARTICLES OF ORGANIZATION OF

Article I

The name of the limited liability company ("Company") is FLORIDA SILT FENCING TRANSPORT & HOLDING, LLC.

Article II

The mailing and street address of the Company's principal office is 4 S. Hwy 17-92, Suite E, DeBary, FL 32713. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

Article III

The period of duration for the Company is perpetual.

Article IV


Article VII


