ARTICLES OF ORGANIZATION OF DELTA SAND COMPANY, LLC

BOMAN S PA FEOS The undersigned, for the purpose of forming a limited liability company under the Florida L Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Article Organization.

ARTICLE I -NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be Delta Sand Company, LLC ("Company"). The principal place of business of the Company shall be 2063 North Monroe Street, Tallahassee, Florida 32303.

ARTICLE II -PURPOSES AND POWERS
