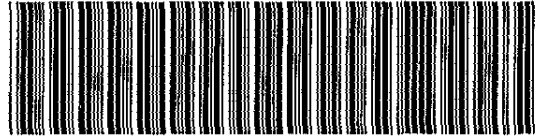

The Articles of Organization for TRW SUMMERPINE, LLC were filed on March 15, 2006.


