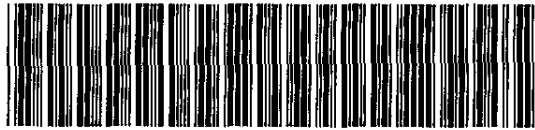

**ARTICLES OF ORGANIZATION  
OF  
FORT OGDEN TRUST, LLC**

1. Name. The name of this limited liability company is Fort Ogden Trust, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

9. Certificated Interests. The members' interests in the Company may be evidenced by certificates, at the discretion of the manager.


