**ARTICLES OF ORGANIZATION
OF

The undersigned, being a duly authorized representative of the member(s), desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 808, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I

NAME
