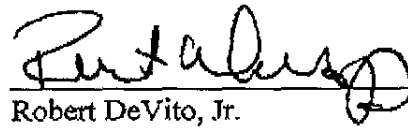

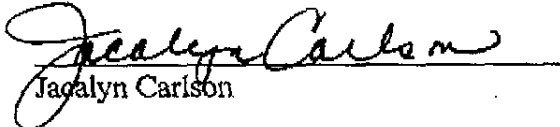
ARTICLE X

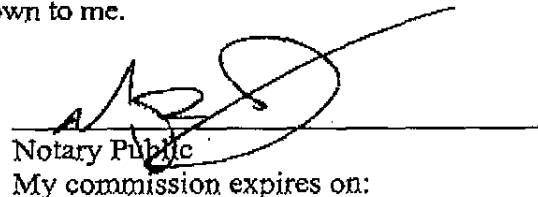

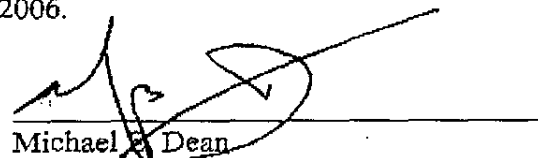
