

1. Name. The name of this limited liability company is Rainbow Cove, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, subject only to the terms of the Operating Agreement.

4. Place of Business. The mailing and street address of the Company's principal office is 5405 Taylor Road, Unit 4, Naples, Florida 34109.

6. Management of the Company. The Company shall be a manager-managed Company, in accordance with the Operating Agreement adopted by the members. 
