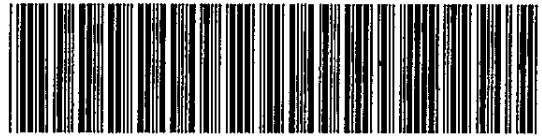



1. The Articles of Organization is amended to read as follows:


The name of this ~~Corporation~~^{LLC} shall be **Gulf+Western Properties, LLC.**
