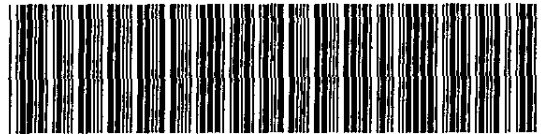



The name of the limited liability company is REGIONAL HEALTH CLINIC, LLC.


ARTICLE II
