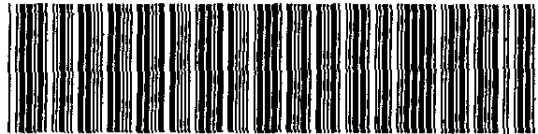



**ARTICLES OF ORGANIZATION
OF

The mailing address and street address of the principal office of the Company is 6110 N. Ocean Boulevard, No. 27, Ocean Ridge, Florida 33435-5241.


ARTICLE III
