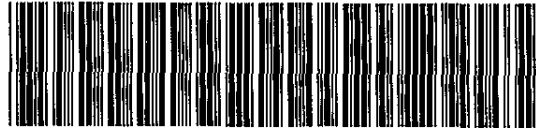

1. Name. The name of this limited liability company is **VAZQUEZ FAMILY LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company's existence shall be effective as of March 20, 2006 and shall thereafter be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

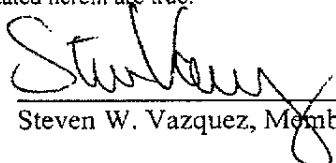
6. Management of the Company. The management of the Company shall be vested in the managers of the Company. The initial manager of the Company is **Steven W. Vazquez**.

The undersigned executed these Articles of Organization this 20<sup>th</sup> day of March, 2006.

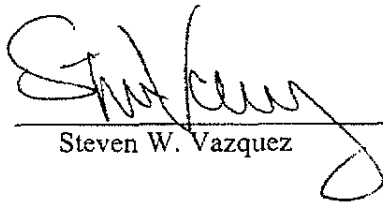
