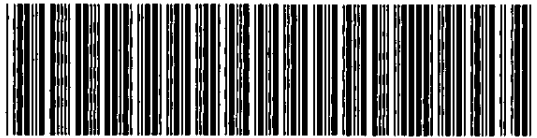

## ASSIGNMENT OF LLC INTEREST

**FOR AND IN CONSIDERATION** of the sum of Ten and no/100 Dollars (\$10.00) the receipt and adequacy of which is hereby acknowledged, **ERIC PORR** ("Assignor") hereby bargains, sells, conveys, transfers, sets over and assigns to **CAPTAIN JACK'S HAULING, RECYCLING & STORAGE, LLC**, ("Assignee") all right, title and interest in and to Assignor's total interest in **CAPTAIN JACK'S HAULING, RECYCLING & STORAGE, LLC** (the "Company"), represented in part by **FORTY-FOUR PERCENT (44%)** ownership interest of **CAPTAIN JACK'S HAULING, RECYCLING & STORAGE, LLC**, a **FLORIDA** limited liability company (the "Interest").

Assignor warrants good, sufficient and absolute title to the Interest and full power and lawful authority to transfer, set over and assign the Interest to Assignee. Assignor further warrants that the Interest is free and clear of all other transfers, assignments and encumbrances of whatever kind or nature.

Assignor agrees to hold Assignee harmless from any and all liability which may arise, in connection with Assignor's ownership interest up to the date of this assignment including, but not limited to, claims, demands, suits, damages, including attorney fees and court costs, or any other damages incidental thereto or any liability therefor.

In exchange for such Assignment, Assignor is granted a **TEN PERCENT (10%)** economic interest in the Company, provided as collateral security *only*, until Assignors real properties are released from the lien of the commercial loans currently held by BB&T on Assignors property. Such economic interest ownership does not entitle holder to any distributions from the company, nor any voting right or power in the company, nor shall it bear any monetary value upon surrender. After said collateral is released from the lien, Assignor's economic interest shall be voided and Assignor shall have no further interest in the Company. Provided that upon any sale of the Company or substantially all of its assets, Eric Porr shall be entitled to 10% of the distributions made to the Members as a result of such sale.
