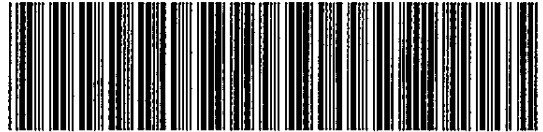

ARTICLES OF ORGANIZATION

OF

AESTHETIC WONDERS, LC

For the purpose of organizing a Limited Liability Company, pursuant to Chapter 608, Florida Statutes, the undersigned submits the following Articles of Organization:

1. The name of the Limited Liability Company shall be AESTHETIC WONDERS, LC.

2. The duration of the Limited Liability Company shall be perpetual.

3. The mailing address and street address of the principal office of the Limited Liability Company is 2510 Azalea Drive, Orlando, Florida 32803.

4. The initial Registered Agent of the Limited Liability Company is Patrick M. Magill, Esquire, whose address is 1234 East Concord Street, Orlando, Florida 32803.

5. The initial members of the Limited Liability Company are:


