### ARTICLES OF ORGANIZATION

## <u>OF</u>

For the purpose of organizing a Limited Liability Company, pursuant to Chapter 608, Florida Statutes, the undersigned submits the following Articles of Organization:

- 1. The name of the Limited Liability Company shall be AESTHETIC WONDERS, LC.
  - 2. The duration of the Limited Liability Company shall be perpetual.
