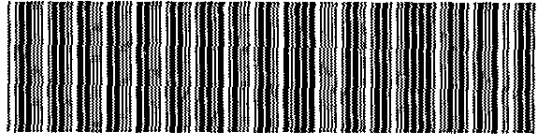

AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
AESTHETIC WONDERS, LC

For the purpose of organizing a Limited Liability Company, pursuant to Chapter 608, Florida Statutes, the undersigned submits the following Articles of Organization:

1. The name of the Limited Liability Company shall be AESTHETIC WONDERS, LC.

2. The duration of the Limited Liability Company shall be perpetual.

3. The mailing address and street address of the principal office of the Limited Liability Company is 3000 N. Orange Avenue, Suite C, Winter Park, Florida 32804.

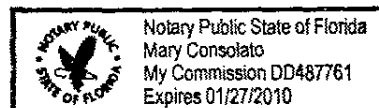
