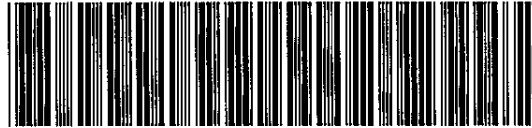

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **COLLEGIATE INSURANCE ADVISORS LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 1499 West Palmetto Park Road, Suite 408, Boca Raton, Florida 33487 and the mailing address shall be the same.


