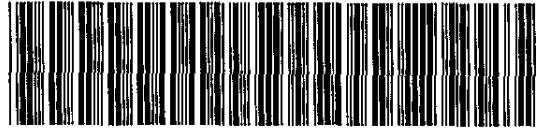

ARTICLES OF ORGANIZATION OF
JCV PROPERTIES, LLC

Pursuant to Chapter 608, Florida Statutes, the undersigned, being a natural person over the age of 18 years, and being a member or an authorized representative of a member of **JCV PROPERTIES, LLC**, hereby forms a limited liability company.

Article 1
(Name)

The name of the limited liability company is **JCV PROPERTIES, LLC**.

Article 2
(Duration)

The duration of the limited liability company shall be perpetual.

Article 3
(Initial Principal Office)

The address of the initial principal office of the limited liability company shall be 401 East State Road 436, Casselberry, Seminole County, Florida 32707.

Article 4
(Registered Office & Agent)

(Additional Members)

No person may be admitted as a member of the limited liability company except upon the unanimous written consent of then existing members of the limited liability company.

In the event of death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, upon unanimous written consent, the remaining members shall have a right to continue the business of the limited liability company.

Article 7
(Management)

The affairs of the limited liability company shall be managed by one or more managers who shall be elected by and hold such offices as may from time to time be determined by a majority of the members of the limited liability company. The name and address of the initial manager of the limited liability company who shall serve until the first annual meeting or until his successor is duly elected and qualified shall be Charles H. Veigle, Sr., whose address is 401 East State Road 436, Casselberry, Florida 32707.

Article 8
(Transferability of Member's Interest)

No member may assign, in whole or in part, his membership interest in the limited liability company without the unanimous written consent of the non-assigning members.


Article 9


