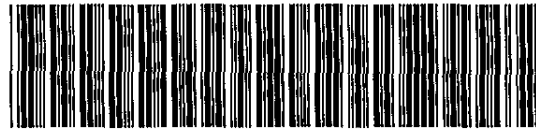

ARTICLE I


