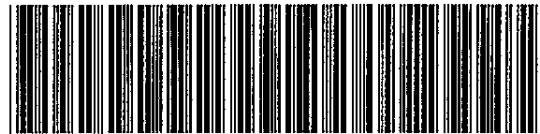


**AMENDMENT TO
