#### Articles of Organization

#### Mortgage Network Services, LLC

#### A Florida Limited Liability Company

- Name. The name of this limited liability company is Mortgage Network Services, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.
- Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
- Purpose. The Company is organized for the purpose of transacting all 3. lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.

- Operating Agreement. The members shall have the power to adopt, alter. amend, or repeal an Operating Agreement for the Company containing provisions for the regulation and management of the affairs of the Company.
- Voting. The Company is authorized to issue membership units with voting rights and membership units without voting rights.
- Certificated Interests. The members' interests in the Company may be evidenced by certificates.
