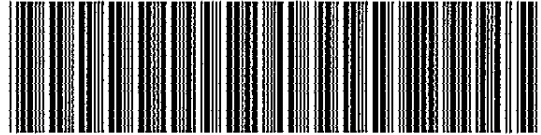

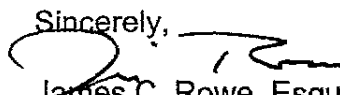

ARTICLES OF ORGANIZATION

1. Name.
