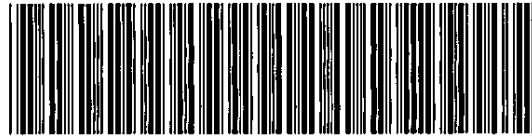




THE UNDERSIGNED, acting as Sole Member of the Limited Liability Company, adopts the following Articles of Dissolution for such Limited Liability Company:

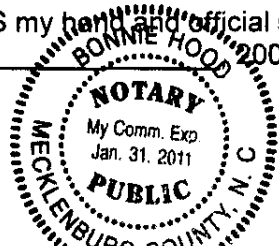
