#### ARTICLES OF ORGANIZATION OF McCALL'S ENTERPRISES, LLC

Control of the second s The Articles of Organization following are adopted for the purpose of organizing a Company under the Florida Limited Liability Company, Act, Chapter 608, Florida Statutes.

#### ARTICLE I

#### Name and Address of Company

The name of the limited liability company (hereinafter referred to as the "Company") is McCALL'S ENTERPRISES, LLC. The Company's street address is 872 Waukeenah Hwy., Monticello, Florida 32344; it's mailing address is 872 Waukeenah Hwy., Monticello, Florida 32344.

#### ARTICLE II

#### Commencement, Duration and Power of Company
