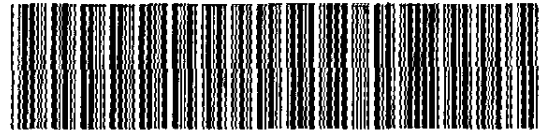

**ARTICLES OF ORGANIZATION
OF

ARTICLE I - Name

The name of the limited liability company is MY FLORIDA TRAFFIC SCHOOL, LLC (the "Company").
