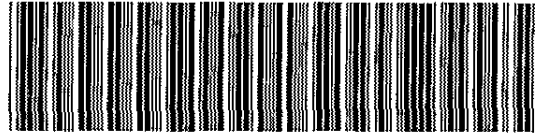


ARTICLE VI - MANAGEMENT
