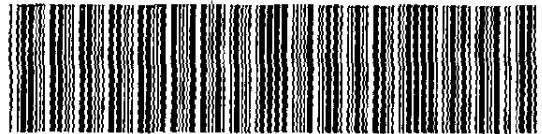

The name of this limited liability company shall be: **LA MARKETING, LLC**


