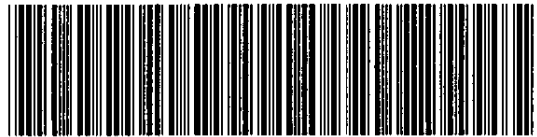


Dear Mr. Bryan:
