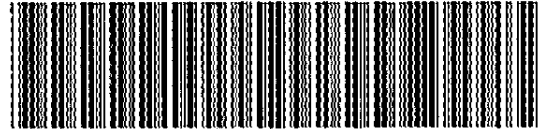

ARTICLE - VI OPERATING AGREEMENT

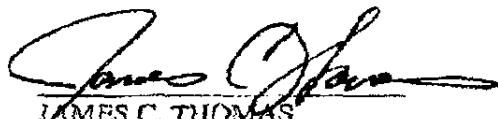

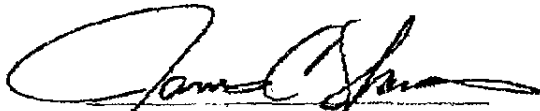
