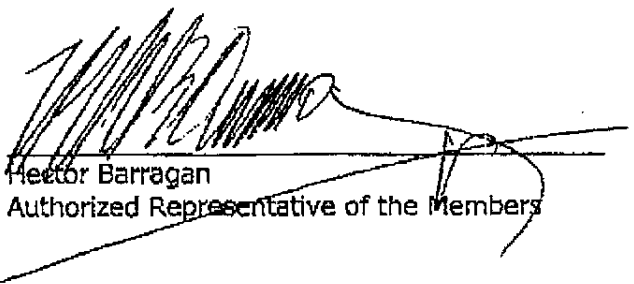
ARTICLE VI. PURPOSE
