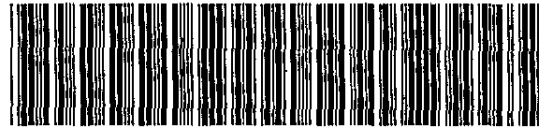

Pursuant to the provisions Chapter 608 of the Florida Statutes ("the Florida Limited Liability Company Act"), the undersigned organizers, Allen & Olson Management Services, L.L.C., Nathan Herrera and Sandra V. Serrano, hereby adopt the following Articles of Organization.

ARTICLE I



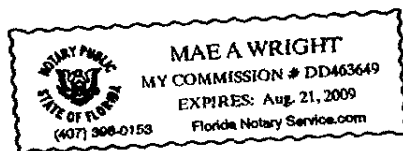
