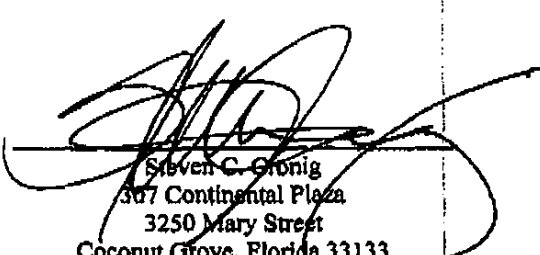
**Second Amendment to Articles of Organization
