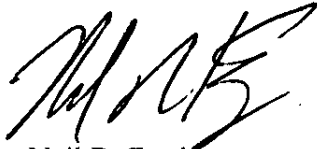

SECOND: The undersigned manager of AHT II, L.L.C. hereby amends the Articles of Organization of the Florida Limited Liability Company to read as follows:

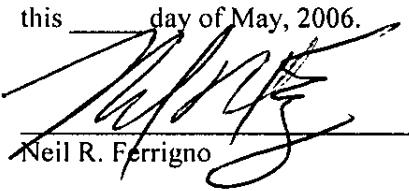

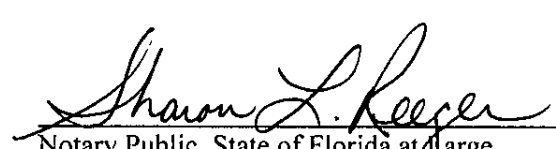

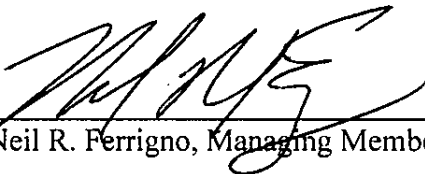
