ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION
OF

FIRST: The Articles of Organization were filed on March 28, 2006, and assigned document number L06000032522.

SECOND: The following amendments to the Articles of Organization were adopted by the limited liability company:

"ARTICLE I
