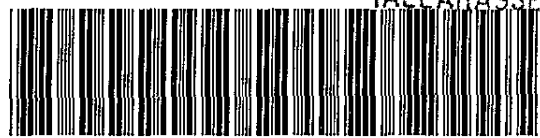

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

**ARTICLE I – NAME**

The name of the limited liability company shall be JC Property Investments, L.L.C. (the "Company").

**ARTICLE II – ADDRESS**

The mailing address and street address of the initial principal office of the Company shall be 9907 N. Happiness Drive, Syracuse, Indiana 46567.

**ARTICLE III – REGISTERED AGENT AND REGISTERED OFFICE**

The registered agent of the Company in the State of Florida is Sheila B. Hieber. The registered office of the Company is 2007 West De Leon Street, Unit D, Tampa, Florida 33606-1643.

**ARTICLE IV – DURATION**

The Company shall commence its existence on March 20, 2006. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.

## ARTICLE V - TERMINATION OF EXISTENCE

The Company shall be dissolved on the death, bankruptcy or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there is at least one remaining member.

## ARTICLE VI - ADMISSION OF NEW MEMBERS

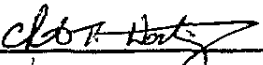
No member(s) shall or may be admitted to the Company except upon the unanimous written consent of all the members of the Company. Any newly admitted member of the Company shall be subject to such terms and conditions as may be determined by all the members. A member may transfer his or her interest in the Company in any manner authorized by the regulations of the Company; provided, however, that the transferee shall have no ability or entitlement to exercise any rights or privileges attendant to membership in the Company or to participate in the management of the business and/or affairs of the Company, unless all members of the Company approve of the proposed transfer by unanimous prior written consent.

## ARTICLE VII - MANAGEMENT

The Company shall be managed by the member(s) in accordance with regulations adopted by the members for the management of the business and affairs of the Company. The regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 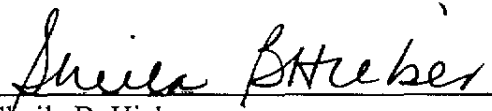
